Shipping Medical Supplies and Equipment:  
Most mission hospitals lack important medical equipment and even  
basic supplies. Global Health Ministries (GHM) gathers donated  
medical items, from exam gloves to ultrasounds, and matches them  
to requests from partners in developing countries. We purchase and  
ship new equipment as well, making quality health care accessible  
for some of the world's most vulnerable people. In 2021 GHM shipped  
13 sea containers in support of hospitals and clinics in 6 countries.  
Twelve travelers hand carried medical supplies and equipment in 23  
suitcases to 8 different countries.

Grassroots efforts: GHM supports efforts to train and sustain  
Community Health Workers (CHW) to build capacity in lower & middle

enduring change. In 2021 GHM supported CHW programs in El Salvador,  
Madagascar, Nicaragua, Nigeria, and Tanzania.

Leadership Training: Upon request GHM offers consultants in

other partner countries. GHM funded 858 scholarships and training  
in 5 countries.
